Subject:- Arrangments in connection with celebration of Eid-Milad-un-Nabi 3.

Divisional Commissioner, Kashmir Shri Pandurang K Pole, IAS, took a meeting on 16.10.2020 at 11.30 AM regarding the arrangements in connection with celebration of Eid Milad un Nabi in Kashmir Valley, especially at Asar-i-Sharief Hazratbal, Jenab Sahib Soura, Kalashpora, Aham-i-Sharief, Bandipora, Kabamarg, Anantnag, bath Makhama, Beerwa, etc & other places of main congregations/shrines/masjids.

The Officers participated in the meeting are appended as Annexure-A.

At the outset the Divisional Commissioner, Kashmir was apprised by Chief Executive Officer, Wakaf Board that a meeting has been conducted with the stake holders, wherein it has been decided that the holy relic will be displayed on 12th Rabiul Awal (outside the building) and during which no person will be allowed to remain inside the shrine/mosque. Besides, the 5 time nemaz (prayers) will be offered on time and no shabkhani (night prayers) will be allowed in all the wakaf shrines/mosques because of the spread of the pandemic Covid-19. Further, all the covid-19 related SOP/guidelines will be followed in letter and spirit.

After, threadbare, discussion and deliberation, following decisions were taken:-

Besides, the filled in septic tanks, if filled shall be cleared through the suckers around the shrine. Similar, arrangements shall be made by ULB/Health Services /Admn. at other shrines/masjid in Districts during the Urs days.

The chair directed that soap shall be made available by Wakaf Board at the main places of congregations in order to prevent the spread of covid-19

Un- interrupted power supply	Chief Engineer, KPDCL, was directed that un-interrupted power supply shall be provided to the main places of congregations/shrines during the Urs days, especially at the prayer/nemaz time. Besides, Gen. Sets shall be kept on standby mode so that the devotees shall not face any inconvenience.
