At the outset, the Divisional Commissioner, Kashmir briefed the participants about the SOPs/guidelines for the containment policy of Covid-19 in Red Zone areas of Kashmir Valley and impressed upon all to adhere the advisories /SOPs in letter and spirit in order to contain the spread of Covid-19 (pandemic).

After threadbare discussions and deliberations the chair directed as under:-

S.No	Decisions taken by the Divisional Commissioner, Kashmir	Action by
1.	Director, Rural Development Department, Kashmir shall ensure 100% distribution of masks through the PRIs/VLWs etc. to every house hold of Red Zone area in collaboration with the concerned district administrations and teams constituted for the purpose, preferably on the same day , the house to house survey is conducted by the teams.	Director RDD/All Deputy Commissioners/ Dir. Health Services Kmr. Etc.
2.	Director, Rural Development Deptt. Kmr, through ACDs shall strictly ensure the immediate action /coordination with the teams/departments after notification of the Red Zone areas of their concerned districts.	Dir, RDD Kmr/All ACDs
3.	Director, Rural Development Department, Kashmir shall ensure immediate cleanliness/sanitization drive of the notified Red Zones, subsequent cleanliness drives after every week (at least 05 drives).The concerned Dy.	Director , RDD Kmr/All DCs

	Commissioner shall provide the labour to the rural department if needed.	
4.	Director, Rural Development Department, Kashmir shall ensure wide publicity of awareness programmes through the mobile/vehicle mounted PA System in every nook and corner of the villages. Police Department shall ensure the hassle free movement of these vehicles.	Director, RDD, Kmr./All SSPs
5.	Director, ULB, Kashmir shall conduct the rigorous fumigation/cleanliness drive in all the Red Zone areas coming under his purview. Besides, shall conduct the fumigation of all the rural Red Zone areas for which Director Rural Dev. Department shall provide him all the consumables /logistic and necessary support.	Director, RDD, Kmr./ULB Kashmir
6.	Dr. Mehta shall take a meeting with the volunteers /Non Govt. Employees of YSS, SDRF and Red Cross and shall roll out plan of action to be executed for the containment of covid-19 in the Valley.	Dr. Mehta
7.	Information Department shall ensure the broadcast/telecast of bulletin/talk of Director Rural Dev./ULB and the assisting officers. Besides, the talks of Public Health Experts of Srinagar Development Authority. Information Department shall also give wide publicity about the Aarogya Setu Mobile app for the download and subsequent awareness about the Covid-19.	JD, Information, Kmr.
