Subject:- Minutes of the meeting held under the Chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner Kashmir on 15.06.2019 regarding inauguration of international Sports Facilities at TRC Ground Srinagar and holding of exhibition Football Match between Indian Stars v/s J&K Stars at TRC Ground Srinagar- Arrangements thereof.

A meeting under the chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir was held on 15.06.2019 at 10.30 AM regarding inauguration of international Sports Facilities at TRC Ground Srinagar and holding of exhibition Football Match between Indian Stars v/s J&K Stars at TRC Ground Srinagar- Arrangements thereof.

List of the participants of the meeting is annexed as Annexure-A.

At the outset the Secretary, Sports Council J&K informed the chair that the facilities at TRC Football ground have been upgraded to the International level, viz, pavilion, artificial turf, toilet block, flood light towers/flood lights etc. Besides the media room for live telecast and the office for State Football Academy has also been built so as to meet the international standards. With these facilities the Sports Council will be able to telecast the matches during the evening/night hours. He further informed that Hon'ble Governor J&K is going to inaugurate the above facilities on 18.06.2018. Besides, the department is also going to hold an exhibition football match between Indian Stars V/S J&K Star on the same date after the inauguration. In this connection the players from Jammu & Kashmir and out of state have been invited for the event. The Transportation, lodging and boarding arrangements have been made by Sports Council itself.

The Divisional Commissioner, Kashmir stressed upon all the participating officers to ensure that all the arrangements are put in place for smooth conduct of both the events. It was impressed upon all the officers of civil/police to maintain close coordination and take initiatives to make the forthcoming event successful. Department-wise arrangements to be made were discussed and preparedness of different departments was assessed.

After threadbare discussion the following decisions were taken:-

1. The details of the teams/guests accommodated by the State Sports Council shall be shared with the Police and Security department for making necessary arrangements. Further, a Liason Officer shall be deputed to the site of accommodation by Dy. Commissioner Srinagar.

(Action by SSC/DC Sgr)

2. The Player/guests shall be escorted by Security Personnel from Airport to Hotel and then Hotel to Venue during the exhibition and practice/training venue.

(Action by SSP Security)

3. The sports council department shall invite the football clubs of Srinagar, Ganderbal, Budgam, Bandipora, Baramulla and Kupwara for the inauguration ceremony/match. The SSP Srinagar shall invite all the commandants of the police battalions, besides, invitation shall be served to Army and CRPF commanders for the event. The Youth Services and sports department shall invite all the Physical teachers/masters for the event. The concerned Deputy Commissioners shall make necessary transportation facilities for the invited teams from their districts.

(Action by SSC/SSP SGR/YSS)

4. Health Department will ensure setting up of medical facilities in and outside the Stadium and will also keep available Critical Care ambulances equipped with appropriate medical teams. Director, Health Services Kashmir will also make arrangement of General Physician and Orthopaedician and other first aid for the event.

(Action by: Dir.HSK)

5. Chief Engineer, PW(R&B) Department, Kashmir will ensure erection of firm barricades in and outside the Stadium in consultation with SSP, Security Kashmir/SSP, Srinagar/J&K Sports Council.

(Action by: CE.R&B/SSP Security/SSP Sgr/Secy. Sports Council)

6. PDD will ensure uninterrupted Power Supply during the occasion viz. 17th & 18th of June , 2019, Standby Generator sets shall also be installed in the Stadium for backup purpose after conducting proper audit of the venue.

(Action by: CE, PDD)

7. The PHE Department will ensure availability of potable water in the stadium through temporary posts/storage tanks. The PHE, Department will also keep standby water tankers at the identified places in consultation with the Sr. Superintendent of Police, Srinagar.

(Action by: CE, PHE)

8. SMC shall ensure cleanliness in and around the Stadium, installation of Mobile Toilets and availability of sucker machines.

(Action by: Commr. SMC)

9. Dy. Commissioner Srinagar will arrange Transportation facility and refreshment arrangements for the viewers/guests.

(Action by DC Sgr)

10. The information department shall install the public address system in and outside of the venue on 17.06.2018 for crowd control and smooth traffic management in consultation with SSP Traffic. Only accredited journalists shall be invited on inauguration day which is on Tuesday 18.6.2018. The Information department shall contact Doordarshan Kendra Srinagar and other channels for live telecast of the event and also shall depute Nodal Officer who will ensure seating arrangements. Besides, transportation of journalists and doordarshan staff. The Dy. Commissioner Srinagar shall also monitor all the arrangements at the avenue.
