Tour Note of Divisional Commissioner, Kashmir to District Anantnag for reviewing the arrangements made for smooth conduct of Shri Amarnathji Yatra 2019.

The Divisional Commissioner, Kashmir ,Shri Baseer Ahmad Khan, IAS, visited the District Anantnag on 14.06.2019 for reviewing the arrangements made for smooth conduct of Shri Amarnathji Yatra-2019, where he inspected the Yatra Facilitation Centers at Qazigund, and Anantnag .During the visit the following instructions were given:

- 1. Dy. Commissioner Anantnag shall deploy Camp Commander assisted by two Assistant Camp Commanders at all Yatra facilitation centers in five days.
- 2. Director Health Services, Kashmir shall deploy Doctors and Paramedical staff at all the Centers including Additional Centers.
- 3. Six centre's shall be established viz, Jawahar Tunnel Prefabricated Hut, Trauma Hospital Gulabagh, R&B Building Qazigund, Walnut Factory Qazigund, FCI Godown Mirbazar and Vessu Migrant Colony.
- 4. A Prefabricated Hut of size 16x48 shall be dismantled from Bemina, transported and erected at the location identified near Jawahar Tunnel by Executive Engineer R&B Division Budgam. The expenditure will be borne by Dy. Commissioner Anantnag who shall release an amount of Rs.2.00 Lacs immediately to Executive Engineer, R&B Division Budgam. Specialized teams for erecting the prefabricated Hut shall be mobilized by Executive Engineer R&B, Division Budgam and same be erected within 10 days positively.
- 5. All vacant accommodation at migrant colony Vessu shall be taken over by the Dy. Commissioner Anantnag for use incase of exigency.
- 6. The under construction building of Trauma Hospital, Gulab Bagh Qazi Gund shall be completed by Housing Board and got white washed, repaired within five days and handover to Dy. Commissioner Anantnag. The boundary wall shall also be completed on the National Highway side.
- 7. Tourism Department shall install bio toilets at all the six additional locations in five days.
- . 8. Additional Toilet points shall be established by R&B/PHE Division Qazigund at all the six identified locations.

- Food Corporation of India shall remove the rice from three halls and hand it over to
  Dy. Commissioner Anantnag in 3 days, and there shall be no truck movement at FCI
  Godown Mirbazar for the first 20 days from the start of Yatra.
- 10.R&B Building at Qazigund shall be repaired by R&B Department and handed over to Dy. Commissioner Anantnag as additional Yatra facilitation centre.
- 11.PDD shall ensure generators and lighting in the entire area of FCI Godown and six additional locations.
- 12 Forty No. of toilets shall be erected at FCI Godown by R&B Division Qazigund with proper water connections and sanitation facility.
- 13. Superintending Engineers of PDD/R&B/PHE shall ensure that all the requirements are fulfilled in time bound manner.
- 14. Additional space shall be carved out for parking of vehicles between Jawahar Tunnel and Qazigund.
- 15. Satellite Phone shall be handed over by Assistant Commissioner (Central), Kashmir to Dy. Commissioner Anantnag for failsafe communication.
- 16. Executive Officer, Municipal Committee Qazigund shall be placed under suspension for being absent at the time of inspection of Walnut Factory Qazigund.
- 17. Halogen lights shall be installed at the Walnut Factory Qazigund for security purposes by PDD in five days.
- 18. The Hall at Walnut factory shall be renovated by whitewashing, electrification, fixing of fans and proper sanitation shall be maintained. Besides, blankets/200 bedding shall be provided by or before 20<sup>th</sup> june 2019 by Deputy Commissioner Ananthag.
- 19. Additional Parking facility for 50 to 70 heavy motor vehicles (HMV's) shall be created at Walnut Factory Qazigund.

While culminating the visit, the Divisional Commissioner, Kashmir stressed to maintain close coordination among the departments to deal with any situation.
