Subject:- Minutes of the meeting held under the Chairmanship of Additional Commissioner, Kashmir on 08.02.2018 regarding finalizing of arrangements for conduct of Objective Written Test for the post of Patwari and Settlement Patwari (Kashmiri Migrants).

A meeting under the Chairmanship of Additional Commissioner Kashmir was held on 08.02.2018 at 3.00 P.M. to finalize the arrangements for conduct of Objective Written Test for Patwari and Settlement Patwari (Kashmiri Migrant) scheduled to be held from 25.02.2018 by J&K Service Selection Board.

List of the participants is enclosed as **Annexure-A**.

At the outset, Additional Commissioner, Kashmir welcomed the participants and sought feedback about the matter from Secretary, J&K Service Selection Board.

Senior Member of J&K Service Selection Board apprised the Chair that Objective Written Test for selection of candidates for the post of Patwari/Settlement Patwari in Revenue Department will be conducted on 25.02.2018 in single shift, from 12.00 Noon to 2.00 P.M. at identified centres in Srinagar district. He further said that this mechanism will bring in transparency and accountability in the conduct of such examination.

After threadbare discussions, the following decisions were taken:-

- 1) Secretary, J&K Service Selection Board will share the list of the 22 identified examination centres with Deputy Commissioner, Srinagar and Sr. Supdt. Of Police, Srinagar/Sr. Supdt. Of Police, Security, Kashmir.

(Action by: Secy, J&K SSB)

- 2) Senior Superintendent of Police, Srinagar will make adequate security arrangements at and around the identified examination centres during the days examinations.

(Action by: SSP, Sgr)

- 3) Senior Superintendent of Police, Security, Kashmir will deploy Police Personnel, male and female contingents, along with frisking

gadgets at the identified examination centres for proper frisking of the intending candidates.

(Action by: SSP, Security, Kmr)

- 4) Deputy Commissioner, Srinagar shall deploy one Magistrate at each examination centre at the identified examination centres on the day of examination.

(Action by: DC, Sgr)

- 5) All other arrangements for smooth conduct of the examinations shall be made by J&K Service Selection Board.

(Action by: Secy, J&K SSB)

- 6) The observer for all centers shall be appointed by the Divisional Commissioner, Kashmir.

(Action by: Div Com office)

- 7) To make the whole examination process fair and transparent, it was decided that no candidate shall be allowed with electronic gadgets including mobiles, pagers etc into the premises of the examination centre.

(Action by: Secy, J&K SSB)

The meeting ended with a vote of thanks to and from the Chair.
