Minutes of the meeting regarding construction of Mini Secretariat Complex at erstwhile Bus Stand, Batmaloo, Srinagar.

A meeting regarding construction of Mini Secretariat Complex at erstwhile Bus Stand, Batmaloo, Srinagar was held under the Chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir on 10.10.2017.

At the outset, the Chair informed that the meeting has been convened in the backdrop of the announcement made by the Hon'ble Chief Minister regarding construction of Mini Secretariat complex on the land which has been got vacated by shifting the Bus Stand to Parimpora. The Chair informed that the Mini Secretariat will house almost all the District Level Offices and desired that every component, including separate parking for the Officials and public visiting the office, shall be taken into consideration while preparing the DPR and should be an "art of architecture".

After threadbare discussions, the following decisions were taken:-

1. Vice Chairman, Srinagar Development Authority shall visit the spot and prepare the details of the land available at erstwhile Batmaloo Bus Stand. He shall share the information with the Chief Engineer, PW (R&B) Department, Kashmir.

 Chief Engineer, PW (R&B) Department, Kashmir shall engage consultants for preparing the DPR in consultation with the Chief Town Planner, Town Planning Organization, Kashmir and the DPR shall be got prepared within three weeks.

(Action by: CE, PWD, Kmr/CTP, Kmr)

3. Deputy Commissioner, Srinagar will prepare the list of the offices which will be required to be accommodated in the Mini Secretariat in consultation with Divisional Commissioner and send it to Chief Engineer, PW (R&B) Department, Kashmir for necessary action.

(Action by: DC, Srinagar)

4. The work on the proposed Mini Secretariat shall be got executed by R&B Department, Kashmir.

(Action by: CE, PWD, Kmr)

5. Director, Economic Reconstruction Agency, Kashmir, who is Nodal Agency for Metro Network, shall provide necessary feedback to Chief Engineer, PW (R&B) Department, Kashmir in this behalf.

(Action by: Dir., ERA)

The meeting ended with a vote of thanks to and from the Chair.
