Minutes of the review meeting held on 08/01/2018 in connection with movement of passengers in AN - 32 Air Force Courier Services between Srinagar & Kargil.

A review meeting was held under the chairmanship of Divisional Commissioner, Kashmir on 08/01/2018 to discuss necessary arrangements in connection with operationalization of AN-32 Air Force Courier Services between Srinagar and Kargil during winters for movement of passengers during of closure of National Highway to Kargil/Leh.

The Chair necessitated the steps to be taken by Civil/Police administration pursuant to the problems being faced by people of Kargil & likewise areas due to the closure of Srinagar–Gumri Road (Zojila Pass) during winters. Hence the need of operation of AN-32 Air Force Courier Service.

The chair impressed upon the imperative nature of subject matter & that all the concerned officers / agencies have to take necessary measures to ensure smooth operationalisation of AN -32 Air Courier Service; whereof, the following decisions were taken:-

Liaison Officer's AN - 32 Air Force Courier Service Srinagar & Jammu 1) shall publish notice for information of intended passengers of District Kargil for enrolling themselves and obtaining Air Tickets from Kargil House Bemina and Jammu as per past practice.

AN-32 Courier Service shall be functional immediately. It was decided 2) that subject to weather clearance the flights would be operated rotational basis.

Boarding facilities for the passengers at Srinagar airport would be made available through Hajj terminal and proper public address system would be put in place.

Airport authorities will provide separate accommodation as per the 5) past practice for the staff engaged for facilitating the Courier Service.

A weighing machine will be made available at the Hajj Terminal by the 6) Airport authority as per past practice.

Dy. SP Anti Hijacking Srinagar was directed to facilitate X-Ray of the 7) luggage and frisking SoP's through the main airport terminal building and further entry through Hajj terminal.

In order to meet any exigency or transporting patients arriving from 8) Kargil, the Director Health Services Kashmir will ensure the availability of an ambulance & Medicare facilities.

Liaison Officer AN-32 Sgr / Jmu) General Manager J&K SRTC will provide sufficient number of buses as per the requirement / requisition made by the Liaison Officer, AN - 32

Courier Service. The requisition will be made by Liaison Officer, AN – 32 Courier Service to SRTC a day prior to the scheduled departure of flight.

10) It was decided that the CRPF personal deployed at the main gate shall facilitate the entry of intending passengers by 08:00 AM on the day of scheduled flight.
