At the outset the chair while welcomed all the participants was apprised by Additional General Manager, IRCON Tulsibagh Srinagar that the Railway Department is going to undertake the process of electrification of railway track from Banihal-Srinagar-Baramulla during night hours apart from day shifts of the work and in this connection sought support from Civil as well as Police Administration.

It was further apprised that, Mast Erection need to be undertaken by using Erection Material Train (EMT). Almost, 12 workers will be at the site in EMT and each EMT will be having two wagons with crane. Moreover, wiring needs to be done by using wiring train. And the approximately 12 workers will be on site. Each wiring train will be having two wagons. In total approximately 24 workers will be on site and the process will take almost 20 days starting from Baramulla to Budgam Section of Railways. If they are that the

After threadbare discussion and deliberation it was directed that SSP / Baramulla/Srinagar/Budgam shall provide adequate security cover to the Railway working teams during all these nights/days without any lapse. In this connection a joint visit of Police/Security/Civil Administration and IRGON shall be conducted within two days so that the vulnerable spots from security point of view shall be covered to prevent any mishaps. Department shall also utilize the services of their Police Wing for the purpose and shall coordinate with Police Department.
