 JK Cements will ensure the availability of cement likely to be supplied to Ladakh Division. JK Cements informed that full stock is available with them.

 SRTC will provide trucks to all line Departments on requisition basis on priority and submit the information on daily basis to Div Com / IGP Traffic about deployment of trucks.

 SE PWD Leh / Kargil will make immediate necessary arrangements for lifting of cement to Ladkah region.

4) Director Food CS &CA Kashmir will ensure the supply of Rice / Atta to District Kargil as per target and other commodities to Ladakh region with immediate effect.

5) All the concerned Departments that have to supply the material to Leh / Kargil Districts will submit daily information to IGP Traffic regarding supply of trucks so that hassle free movement is ensured on the Srinagar – Leh road by Traffic Department. Besides IGP Traffic will allow cement trucks from store at Athwajan to Bye Pass Crossing at Pantha Chowk except peak traffic hours after verification of genuiness of the supplied material / commodity.
