Subject: Review of Mutton Rates/Arrangements in connection with observance of Shab-i-qadar/Juma-tul-vidda and Eid-ul Fitr.

The Divisional Commissioner, Kashmir Shri Pandurang-K-Pole, IAS, took a meeting on the subjected cited above with the stake holders on 19.05.2020 at 2.30 PM in which following decisions/instructions were given to the various Departments.

The officers participated in the meeting are appended as annexure "A".

After threadbare discussion and deliberation following decisions were taken:

1.	The mutton rates shall be finalized after the Eid-ul-Fitr after getting the feedback/analysis/comments from the Deputy Commissioner, till that time the mutton shall be sold at the already finalized rates. Anybody found violating shall be booked.	All DCs/Dir. FCS&CA
2.	All the Deputy Commissioners shall ensure submission of proposed mutton rates to this office after taking on board to all the mutton dealers/sellers after Eid-ul-fitr.	All DCs
3.	All the Deputy Commissioners/SSPs shall ensure that the shop keepers are following all the covid-19 related SOPs in letter and spirit, and in case of any violation such shop keepers shall be booked and put behind the bars.	All DCs/ SSPs
4.	The Joint/ rigorous market checking teams comprising of FCS&CA Deptt/Revenue/Police/SMC/Legal Metrology/ Drug & Food Safety Standards Deptt shall ensure market checking to check profiteering/black marketing of essential commodities by traders (wholesalers/retailers) and ensure availability of essential commodities like Mutton, Chicken, Vegetables, fruits, Bakery and confectionery etc in the markets as per the notified rates with standard quality and maintenance of better relations between Administration and the general public.	All DCs/ FCS&CA/ Legal Metrology/ Drug & FSS Deptt /
5.	Controller, Drug and Food Safety Organization was directed by the chair to ensure that the standard quality of food items like Bakery & confectionery products, snacks, soft drinks, spices and other food stuffs are available in the market.	Controller Drug & FSO

6.	The PDD Deptt. shall ensure uninterrupted power supply on the eve of Jumat-ul-Vida , Shab-i-Qader and Eid-ul-Fitr especially.	CE. KPDCL
7.	The PHE Deptt. shall make adequate measures for providing of water supply on Jumat-ul-Vida , Shab-i-Qader and Eid-ul-Fitr. They will also ensure availability of Water through tankers at the places where needed.	CE, PHE, Kmr.
8.	The FCS&CA Deptt. Shall make all possible arrangements for availability of ration i.e Rice, Atta, Sugar, K-oil and LPG cylinders in buffer stock on these occasions as per notified rates of standard quality.	Dir, FCS&CA
9.	The SMC/ULB shall launch cleanliness drive at the mosques /shrines. Besides, they will also ensure that all street lights are made functional.	Com. SMC/Dir. ULB
10	SMC shall ensure frequent checks of the markets to ensure availability of quality food products like mutton, chicken, bakery, milk, vegetables, fruits etc in Srinagar city on the already fixed rates and incase of violation such persons shall be booked.	SMC
11	The Animal Husbandry Deptt. shall ensure the availability of poultry birds on notified rates.	Dir.AH Deptt.
12	Police authorities shall prepare a separate security plan on the eve of Jumat-ul-Vida, Shab-i-Qader and Eid-ul-Fitr functions	IGP Kmr/SSPs

Summing up the meeting, the Chair desired that:-

- All the departments must adhere to the Cvoid-19 SOPs and implement them on ground in letter and spirit.
- Ensure strict compliance as per the decisions taken.
- The essential commodities shall be made available as per notified rates and standard quality.
