Subject:- a). Implementation of Solid Waste Management Rules 2016, issued by Ministry of Environment, Forest and Climate Change.

b) Sustained Anti-encroachment drive and action taken thereof.

c). Back to Village Programme-Uploading data by 12.07.2019 and its analysis in order to priority by Deputy Commissioners.

A meeting under the chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir was held on 15.07.2019 at 11.00 AM regarding the subject matter.

List of the participants of the meeting is annexed as Annexure-A.

Besides, Deputy Commissioner, Budgam/Pulwama/Shopian/Anantnag/Kulgam/ Baramulla/ Kupwara/Bandipora/Ganderbal participated in the meeting through VC.

At the outset, the Chair stressed that focus should be given to the time lines which have been prescribed by the Worthy Chief Secretary /Government agencies with regard to Implementation of solid waste management rule 2016. Besides, routine discussions/action shall be taken on monthly basis for sustained antiencroachment drive and the submission of information as per proforma devised by Housing and Urban Development Department. The Deputy Commissioners of Baramulla and Bandipora were appreciated by the chair for timely submission of requisite information.

Thereafter, all the Deputy Commissioners of Kashmir division apprised the Chair with regard to identification of land for solid waste management plants, the action taken report and meetings held on the issues. It was further appraised that the land for the left over Muncipal committees shall be identified today. Further, all the DC's informed that the process of retrieval of encroached land is in active process and hundreds of kanals of land has been retrieved. Besides, the list of high value 30 encroachers of kacharia, state land etc have been formulated and shall be submitted



today. The DC Srinagar informed that 200 kanals of land have been retrieved from Parimpora and 32 kanals of land from Eidgah Srinagar. The retrieved 32 kanals of land at Eidgah has been handed over to the Sports Department. The data of "back to village program" have been uploaded and the process of its rechecking /authentication is going on war footing basis.

The Dy. Commissioner Baramulla and Budgam informed that for the solid waste management segregation at source, the municipal committees of these districts requires 8000 and 5000 dustbins respectively.

After threadbare discussions, the following decisions were taken:-

Deputy Commissioners shall submit sustained Aanti- encroachment drive/action taken report to this office regular basis, besides, shall submit list of 30 high level encroachers who have resorted to encroachment of kachari/state land etc, so that the action under law shall be initiated against them. In case instance of any new encroachment at any place the concerned Patwari shall be put immediately under suspension and action as warranted shall be taken.	All DC's
3.	Deputy Commissioners shall complete the process of upload of data of "Back to village program" within two days after proper check/authentication and shall prioritize the urgent nature of work for its execution.	
4.	Deputy Commissioner shall convene periodically meetings of the committee constituted under section 12 of SWM Rule 2016 and the SSP concerned being member shall be taken on board. Besides, the quarterly reviewing meetings on local bodies shall be conducted and the minutes of which shall be submitted to this office.	All DC's

The Deputy Commissioners of Baramulla, Kupwara and 5. DC Budgam shall submit the action taken report of the Baramulla/Kupw instructions/direction given on various issues and minutes ara/Budgam of meeting held in the recent District Review meetings by evening today.
