**Subject:** Minutes of the meeting regarding arrangements for the Celebration of the Birth Anniversary of Guru Hargobind Sahib Ji Maharaj.

To finalize the arrangements for the celebration of the Birth Anniversary of Guru Hargobind Sahib Ji by the Sikh Community on 29<sup>th</sup> of June, 2018, a meeting was held under the Chairmanship of Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir on 23.06.2018 at 2.00 P.M.

At the outset, Divisional Commissioner, Kashmir impressed upon the Officers to make elaborate arrangements pertaining to their respective departments for the occasion in an effective and efficient manner so that the religious sentiments of this community are respected and reciprocated.

After threadbare discussions, the following decisions were taken:-

He shall also discuss the arrangements with the Management of the respective Gurudwaras. This exercise shall also be undertaken by Deputy Commissioner, Budgam/ Baramulla/ Pulwama/ Anantnag. 2.	Srinagar Municipal Corporation shall conduct special sanitation drives at all the Gurudwaras in District Srinagar on the said occasion. 3.	Arrangements for uninterrupted electricity shall be made at all the venues. Gensets shall also be kept at standby to meet any eventuality. Besides, arrangements for installation of lights on Gurudwara Chattipadshahi, Rainawari; Gurudwara Jawahar Nagar; Gurudwara Amira Kadal and Gurudwara Baghat shall be made by Power Dev. 4.	Arrangements for uninterrupted water supply on the occasion to the Gurudwaras shall be ensured by PHE Department, Kashmir. Besides, the department shall ensure availability of tankers to meet the requirements of potable water.	CE, PHE, Kashmir

Director, Civil Supplies, CA&PD Department, Kashmir shall ensure availability of Atta, LPG, sugar to the Management of the Gurudwaras against cash payments at reasonable rates for langars being organized by the Sikh community at the Gurudwaras on the occasion.	Dir., Civil Supplies, CA&PD Department, Kashmir
6.	Director General, Health Services, Kashmir shall ensure establishment of medical camps at the Gurudwaras on the occasion and shall deploy doctors/para-medics. Besides, medicines and first aid shall be kept available in the camps. Ambulances shall be kept on standby at the venues where huge congregations will be held.	DG, Health Services, Kashmir
7.	Elaborate and adequate transport arrangements, especially for the devotees coming from other districts of the Valley to Srinagar shall be made by the concerned.	MD, SRTC, J&K RTO, Kashmir
8.	Arrangements for streamlining/regulating of traffic shall be made by SSP, Traffic, City, Srinagar. Besides, he shall visit the spot to identify the space for parking of the vehicles of the devotees on the auspicious day.	SSP, Traffic City, Srinagar
9.	Preponing of the holiday on account of the celebration of the Birth Anniversary of Guru Hargobind Sahib Ji from 5 <sup>th</sup> of July, 2018 to 29 <sup>th</sup> of June, 2018 shall be taken up with the Govt.	ACC with Div Com (K)
