Subject: Minutes of the meeting held on **25-07-2018** regarding Traffic Management & various developmental issues in Srinagar City.

A meeting was held under the chairmanship of Divisional Commissioner Kashmir on **25-07-2018** at **4. 00 PM** regarding the subject hereinabove.

Following officers attended the Meeting:

1. Inspector General of Police, Traffic, Kashmir.
2. Deputy Commissioner, Srinagar.
3. Chief Engineer, PWD (R&B) Kashmir.
4. Commissioner, Srinagar Municipal Corporation.
5. Superintending Engineer, PWD (R&B) Srinagar.

At the very outset, the Divisional Commissioner Kashmir apprised the participants about the importance of decongestion of traffic in Srinagar city and sought report from participants on various works being undertaken by line departments and reasons for bottlenecks; if any.

After threadbare discussions, following decisions were taken:

1. Commissioner Srinagar Municipal Corporation will ensure that no street vendor is allowed to run business at Harisingh High Street and Jehangir Chowk. It shall be ensured that the vendors in this stretch are shifted to Khalsa School Parking immediately. Deputy Commissioner, Srinagar will provide executive magistrates and the police assistance shall be provided by the SSP Srinagar.

2. Men and machinery shall be deployed at Karan Nagar Srinagar tonight for removal of encroachments and security personnel be

deployed for maintenance of law and order.

(Action by Commr. SMC/SSP Sgr./SHO Karan Nagar)


3. A speed breaker to be established at Hawal Srinagar. Three speed breakers to be established from Badyari Chowk to Police chowki. Besides, as per requirement, dividers shall be established from Gupkar Road to GB Panth Hospital.

(Action by CE PWD)

4. Commissioner, Srinagar Municipal Corporation shall report the quantum of outsourced parking lots around the Residency Road Srinagar and adjoining areas of Municipal limits where parking lots have been outsourced.

(Action by Commr. SMC)

5. The Divisional Commissioner Kashmir shall visit the Srinagar city at 5:30 P.M on 26-07-2018 to take stock of various developmental projects and also make spot visit to the works being undertaken on Grade Separator at TRC. He shall be accompanied by Deputy Commissioner, Srinagar and officers of line departments.
