Subject:- Issues pertaining to Northern Railway in Kashmir Valley.

Divisional Commissioner Kashmir Chaired a meeting of following officers on 16.10. 2021 in his office chambers with regard to following issues:-

- Construction of approach road leading to Railway Station from Qazigund to Baramulla.
- Reconciliation of Red account in Kashmir Valley.
- Allotment of land at Gulmarg for Holiday Home in lieu of Tangmarg.
- Requestion of Additional Funds from Northern Railway.
- Issues of Staff Engaged.

Following Officers participated in the meeting.

- 1. Dy. Chief Engineer, USBRL Northern Railway.
- 2. Collector Land Acquision Northern Railway, Srinagar/Budgam.
- 3. Dy, CAO, USBRL Northern Railway.

At the outset the chair while welcoming the participants was apprised that Collectorate Northern Railways Srinagar/Budgam is in dire need of following additional funds for which the communications have been addressed to Railway Authorities:-

- 1. Rs.4.53 Crore for compensation to the land owners on accout of pending land/tree compensation.
- 2. Rs.7.00 Lacs incidental charges on account of retainership and counseling fee of court cases.
- 3. Administrative expenses @ Rs.5000/= per month on account of stationery items amounting Rs.60.00 thousands.
- 4. Salary for working staff from August 2021 to July 2022 to the tune of Rs. 0.60 Crores required for smooth functioning of Railway Collectorate Srinagar/Budgam as the collectorate is under obligation to release their wages as per Hon'ble Court Directions.

Thereafter, the chair raised the issue with regard to the temporary employees viz, Chainman/Khalisis and other staff (24 Nos) who have been engaged by Northern Railways in whose favour the Honble Court has given interim relief and forwarded the same to CAT Jamu.

After threadbare discussion and deliberations following directions were passed:-

wages. Besides, as per the Hon'ble Court directions the staff cannot be disengaged and advised that	
Railways should process for inclusion of party in the court cases, thereby filing objections, and till the final disposal of the case by Hon'ble Court their wages shall be paid monthly. Moreover, with regard to the instant matter, Railways should take guidance from the Legal Cell of Northern Railway and also brought to the notice of Higher Authorities at an earliest.
