Minutes of Meeting.

Subject:- To examine and workout the modalities for screening of films/ movies in Government auditoriums in uncovered districts of the state----- Meeting thereof.

A meeting under the chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir was held today on 22.10.2019 regarding the subject cited above.

List of the participants is annexed as Annexure-A.

At the outset, Divisional Commissioner Kmr sensitized the participants about the need of using the auditoriums for screening films, documentaries which have educational, recreational value for general public. It was decided that to begin with, this activity shall be started in Srinagar/Baramulla/ Kupwara districts and subsequently in other districts as well.

After brief discussions on the issue the following instructions were passed:-


1. Deputy Commissioner Srinagar in consultation with Director information and Director Archaeology and Museums/ Secretary J&K Academy of Art Culture and Languages shall screen the film/ documentary at the auditorium of Director Information J&K Sgr (Poloview) within five days. He shall provide date and time to this office by tomorrow. Subsequent events shall be held at Tagore Hall Srinagar after its repairs are completed and the same is communicated by Secretary J&K Academy of Art Culture and Languages.
2. Deputy Commissioner, Baramulla and Kupwara shall also screen films/ documentaries at the auditoriums identified by them on the dates conveyed by them to this office by or before 28th of this month.
3. Director Information, J&K Sgr shall provide quality films/ documentaries to the respective Deputy Commissioners.
