Subject:- Meeting regarding arrangements for conducting of MBBS University Examination- 2019.

A meeting under the chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir was held on 26.08.2019 at 12.30 PM regarding the subject cited above.

At the outset the Chair stressed upon the importance of conduct of MBBS examination on the scheduled dates and accordingly asked Principal GMC Srinagar to brief about the schedule /No. of students appearing in the said examination. The Principal GMC Srinagar & Associated Hospitals appraised the chair that the College is going to conduct the examination of Pre-final MBBS on 5th, 9th & 12th of September 2019 and 1st Year examination from 24.09.2019. The venue of said examination shall be at Government Medical College Srinagar and University of Kashmir. 300 students are expected to appear in the said examination. The Principal GMC requested for making arrangements for movement of students so that they can reach the College by or before 01.09.2019. Accordingly, the Chair assured that full logistic support shall be provided by the concerned Departments in smooth conduct of the said examination.
