



**C I R C U L A R**

Whereas, it has been noticed that the building material in the shape of sand, bricks, bajri, earth, dust, cement etc. is being transported uncovered which leads to the flying off, of the material particles causing air pollution and other environmental issues, besides also polluting water bodies in the process;

Now, therefore, in order to overcome this menace it is enjoined upon all the stake holders to ensure that the material is covered properly with tarpaulins during transportation to different locations. In case any person is found violating these instructions the vehicle carrying such material shall be impounded by the Police/traffic authorities and dealt as per the provisions of law.
